Candidates are also being advised by post. For type test/skill test candidates may come with typewriter for Cat. No. 22 & 28 at the time, date and venue mentioned above. And for document verifications Candidates are required to attend the office of Railway Recruitment Board, Jammu as per date of documents verification given above, with their original certificates and marks sheets (semesterwise / yearwise) of Educational / Technical qualifications, Caste certificates, Proof of age etc. and also their Photostat copies attested by a Gazetted Officer, for verification.

The candidates belonging to OBC Community should bring their original Caste Certificates in the prescribed format of the Central Govt., issued for the current year and valid on the date of verification of certificates, the caste certificates should be current and should have clause of non-creamy layer. Those candidates, who fail to turn up on due date or report without proper certificates, their candidature, will be cancelled. The candidates who do not possess the requisite qualifications, as noted while document verification, their candidature shall stand cancelled / rejected.

Though the letters to individual candidates are being sent but RRB will not be responsible for the postal delay or wrong delivery, if any. Those candidates who do not get Call-Letters/Letters may contact the office of the RRB/J-S/Jammu in person between 1000hr to 1730hr on one day before of the date of skill test/documents verification.
