Eligible candidates have been classified into above two categories as per their technical qualifications and eligibility for them. Empanelment to various categories will be made of successful candidates clearing the document verification as per their preference subject to merit and vacancy position. However, RRB reserves the right to allot even non preferred post and/or railway/unit subject to merit and vacancy position.

In order to take care of any probable shortfall in the formation of panels of various categories, extra candidates (over and above the actual number of vacancies) are being called for. It is also made clear that merely calling a candidate in the Main List or in the Wait List for document verification does not in any way entitle him/her for final empanelment/appointment on the Railways. The candidature of all the above mentioned candidates are purely provisional and subject to correction/amendment arising out of their entitlement and eligibility in all respects for which the administration reserves the right to rectify the error at any stage from empanelment to appointment, and even after appointment.

Candidates are required to attend the office of Railway Recruitment Board/Jammu as per date of document verification indicated above, with their original certificates and marks sheets (semester wise, year wise) of educational/technical qualification, caste certificate, proof of age, J&K resident to bring original state subject certificate etc. and also their Photostat copies attested by a Gazetted Officer, for verification. Even if any of the above candidates are not able to download the call letter for document verification, he/she must also attend this office for document verification as per above schedule. The candidates belonging to OBC community should bring original caste certificate in the prescribed format of the Central Government, issued for the current year and valid on the date of verification of certificates, the caste certificates should be current and should have clause of non creamy layer. Candidates should come with all the documents in original. Candidature of those candidates shall stand cancelled/rejected if it is found during document verification that they do not posses the requisite qualifications or failed to satisfy the eligibility criteria.

Provisionally eligible candidates can download the call letters for document verification from RRB/Jammu website i.e. www.rrbjammu.nic.in. Individual intimation is also being sent through SMS alerts and E-mail.

While every care has been taken in preparing the result, the possibility of inadvertent errors cannot be ruled out. RRB, Jammu does not take responsibility for such errors and reserves the unfettered right to rectify the same at later date.
